## Read these terms and conditions

- **Unioncard and association charge:**  
Every member is obliged to have a valid Unioncard/Campuscard (see [dms.utwente.nl](http://dms.utwente.nl)). Every member is also obliged to request membership for DIOK at the DMS site. When you are accepted you are obliged to pay the association charge.
- **Automatic payment:**  
By filling in this application form you obligate yourself to pay the annual contribution plus the one-time registration fee. If you allow D.B.V. DIOK to automatically withdraw money from your bank account, the contribution will be withdrawn from your bank account in October or November. When you become a member after November during a season, the one-time registration fee and the first contribution will be withdrawn from your bank account within 3 months after becoming a member. Participants costs of events will be withdrawn from your bank account after an event. Every automatic withdrawal of money happens in the last week of a month and will be announced and specified via e-mail at least 5 days in advance. Automatic withdrawal of money can be stopped at any time by sending a written notification to the cashier and will be stopped automatically when the membership is terminated.
- **When a member disrespects the rules of this application form:**  
If the member listed on the front side of this application form does not obligate to these terms and conditions, having the valid Unioncard/Campuscard, payment of the association charge, and payment of the annual contribution, the board of DIOK can take action. The board of DBV DIOK has the right to claim all costs that are a consequence of not obligating to these terms and conditions those actions by the member listed on the front side of this application form on that member.
- **Termination of the membership:**  
Terminating the membership always has to be done by sending a written notification to the secretary of D.B.V. DIOK (via [www.diok.nl](http://www.diok.nl) or put it in the DIOK-mailbox). A member stays a member until the written termination of the membership is confirmed by the board of D.B.V. DIOK. If a member does not terminate his or her membership before August 1st of the current season, the member automatically stays a member for the next season.
- **Change of personal data:**  
The house regulations obligate every member to send a written notification within 30 days to the secretary of D.B.V. DIOK (via [www.diok.nl](http://www.diok.nl) or put it in the DIOK-mailbox) of changes in data like living address, e-mail address and student / employee number, telephone number or bank account number.

## Information and other data

- **DIOK-mailbox:**  
The DIOK-mailbox can be found in the sports centre, near the main entrance on the right of the porter.
- **Contribution:**  
The contribution is set annually in September. For 2015-2016 the contribution is as follows:
  - € 37,50 for recreational players without training and beginners
  - € 44,50 for training players with nylon
  - € 50,00 for competition players with nylon
  - € 69,00 for training players with feather
  - € 80,00 for competition players with feather
  - € 2,50 registration fee (one-time)If you become a member after February 1st, you only pay a half year contribution for the year in which you become a member. The half year contributions are half the yearly contributions mentioned above. For beginners it is possible to hire a racket for a whole year for € 5,00. Hiring a racket is only possible in the first year of the membership. After that you need to buy your own racket.
- **Number of trainings a week:**  
Beginners, recreational players with training and substitute players get one training a week. Competition players have two trainings a week. Besides that every member can play for free on Thursday from 21:00h until 23:00h, during the club evening in sports hall 2.
